TO WHOM IT MAY CONCERN:

Violence in our community takes many forms and is a major concern for everyone today. The Bernalillo County Community Health Council has spent several months with multiple partners planning a convening for organizations and individuals concerned about and/or working on various aspects of violence. The purpose of this convening is to connect the causes and consequences of all forms of violence – from child abuse to intimate partner violence to gun violence – hopefully resulting in a multi-sector initiative that will address the prevention of violence from multiple angles as a public health issue.

Because of the importance and urgency of finding solutions to violence, we are making this event free of charge to the community and we are anticipating approximately 200 participants. In order to support that, the City of Albuquerque is generously sponsoring the venue costs at the Albuquerque Convention Center. However, the cost of the lunch and breaks cannot be covered by any government funds, and for this reason we would like to invite you to participate as a financial sponsor of this day-long convening to help cover those costs.

Our day will consist of a keynote presentation by District Attorney Raul Torrez, followed by a panel of experts in various forms of violence. There will then be two rounds of breakout sessions focusing on those different forms of violence, as well as community-based solutions for prevention. The day will conclude with small table-top discussions about opportunities for collaboration, the potential for an ongoing coalition or initiative, and next steps.
